How Do I Sign Up?

- 5. Complete FastTrack App training

How Does the Rebate Process Work?

Contractors will use a web app to collect data about the existing HVAC equipment and the residence. The app will provide an offer, which shows the customer and contractor how much this particular customer may save by replacing their HVAC system, based on their historical electric usage and the equipment and building data provided by the contractor. The offer will include the applicable Ameren Missouri rebates. The utility will cover part of the cost of the project, and the customer will pay back the utility on their monthly utility bills through on-bill financing.

If the customer accepts the offer, the contractor will install the equipment and complete the application in the web app. The utility will pay the contractor for the amount covered by the tariff, and the customer will pay the contractor any portion of the project not covered, and will repay the utility through on-bill financing.

Participating contractor status does not imply an Ameren Missouri endorsement of the contractor in any way; rather, it simply identifies contractors who have completed the required program training and committed to actively promoting the program and completing the incentive form for customers.
